PROMOTING COUNTRY DIALOGUE

EAs part of the identification mission carried out by the Programme in Peru in 2017, meetings were held with 24 institutions, generating a total of 48 requests for support in its public policies (actions). In 2020, four pre-dialogue round-tables have been held virtually, due to the pandemic, in order to coordinate requests and monitor actions. In 2021, the accompaniment process continues.

Area: Gender equality policies

Line of action: Parity

- ▶ The National Office of Electoral Processes works to promote parity and prevent electoral violence in Peru.

Line of action: Violence; sexual and reproductive health and concepts of masculinity

- ▶ The Peruvian National Police is being supported in the prevention, care and punishment of sexual harassment, as well as with the Violence Against Women Prevention Plan.
- ▶ Creation and implementation of the National Observatory and Regional Observatories on Violence against Women and Members of the Family Group, promoted by Law No. 30364. A coordination space was also created under the responsibility of the Ministry for Women and Vulnerable Populations for the design of public policies for the prevention/punishment and eradication of violence, along with an associated statistical tool.

Line of action: Mainstreaming, budget and statistics

- ▶ Support for the formulation and approval of the new National Plan for Gender Equality (2018-2022).
- ▶ Support for preparing tools to incorporate the gender perspective into the judiciary in jurisdictional and administrative authorities.



Area: Democratic governance policies

Line of action: Public finances

- ▶ Technical assistance for the spending review on the Family Violence Budgetary Programme in Peru and the regional action to evaluate public spending with a gender focus.

Line of action: Regional development

- ▶ Support for the creation of regional development agencies to improve vertical and horizontal coordination.

Line of action: Access to justice

- ▶ Improving access to justice for children and adolescents with a comprehensive approach to protecting rights in their relationship with the judiciary in Peru.

Line of action: Good governance

- ▶ We are drawing up a proposal for an integrity barometer to ensure that public entities implement Peruvian Technical Standard ISO 37001 on Anti-Bribery Management.
- ▶ We are working towards an amendment to the Political Organisations Act on the regulation of party financing.
- ▶ We are promoting the strategy and the promotion of the integrity system in the Peruvian public sector.
- ▶ Strengthening the new specialised district system on crimes involving the corruption of officials in the Peruvian judiciary.



Area: Social policies

Line of action: Social inclusion policies

- ▶ We are designing the Social Programmes [Register and the National User Register](#) through the implementation of the Social Information Exchange Mechanism.
- ▶ We will start supporting the Ministry of Health to implement a family care model as a point of entry to the health system.

Line of action: Active employment policies

- ▶ Support in creating an integrated centre for advisory services and support for the formalisation of work and business called Centro Formaliza Perú. In 2019, the Ministry of Labour and Employment Promotion used the Manual as an input for the regulatory instruments for Formaliza Perú integrated centres. In the last two months of 2019, four centres were opened with ten more are scheduled to open in 2020.
- ▶ We provide technical assistance to the Ministry of Labour and Employment Promotion in the implementation of the strategy to formalise domestic workers within the framework of the recently approved Law No. 31047/2020, as well as facilitating dialogue and an exchange of experiences in the countries of the European Union and Latin America.

Line of action: Care policies

- ▶ We work with the MSSA to strengthen the Protection Network for the Elderly and People with Disabilities within the framework of Covid-19.
- ▶ The manuals for strengthening strategies for the care of persons with disabilities were delivered to the Unit for Services for the Protection of People with Disabilities, which has six attached Residential Reception Centres that serve a population of children and adolescents with multiple disabilities.
- ▶ The design of a Municipal Model for the Detection and Eradication of Child Labour in Local Governments will begin with the Ministry of Labour and Employment Promotion.

REGIONAL ACTIONS

- ▶ Definition of a Regional Strategy for the Access to Justice Model with the Conference of Ministers of Justice of the Ibero-American Countries.
- ▶ We are supporting the drafting of version 2.0 of the Inter-American Framework Law on access to public information with the Organisation of American States.
- ▶ In Multi-Country Actions, the Peruvian Ministry of Foreign Affairs is participating together with the Bolivian Lake Titicaca High Authority, in territorial cooperation on the management of Lake Titicaca.
- ▶ Evaluation of public spending in Latin American countries with a gender focus.
- ▶ Participation with the EU-LAC Foundation to study the links between vocational training and professional technical education and the productive world.
- ▶ With the Pacific Alliance countries, the installation of an integrated system for the approval of migrants' employment certifications and in the creation of integrated and certified virtual training to face the consequences of Covid-19.
- ▶ Latin America Tax Education Network, to implement the Tax and Accounting Assistance Hubs.
- ▶ International Taxation Network at the Inter-American Centre for Tax Administrations.
- ▶ In association with the Ibero-American Association of Public Prosecutor's Offices, participation in institutional strengthening to combat the differentiated impact of corruption on women. And in Cooperation in the fight against corruption.
- ▶ Collaborative implementation of the Document Management Model in association with the Transparency and Access to Information Network. There is also involvement in the action on transparency and access to information for groups in vulnerable situations and in the consolidation of a regional measurement system for the right of access to information.
- ▶ Implementation of the New Brasilia Rules and improving access to justice for vulnerable populations through the Ibero-American Judicial Summit. Implementation of the gender equality perspective within the Ibero-American Judicial Summit.
- ▶ Definition and implementation of the Regional Guide for action in cases of institutional violence and in creating a network and model for legal assistance to migrants within the framework of the Inter-American Association of Public Defenders.
- ▶ Working with the Association of Electoral Magistrates of the Americas in strengthening its Regional Observatory on Parity Democracy, Harassment and Violence.
